


**SOUTHERN TRINITY GROUNDWATER CONSERVATION DISTRICT

In open session, the Board may discuss and take action on any matter for which notice has been given in this Notice, including the agenda item posted for closed session. In no event, however, will the Board take action on any agenda item in closed session, whether it be posted for open or closed session discussion.
