ORDER GRANTING WORK OR EDUCATIONAL RELEASE

It is therefore, **ORDERED** that the Sheriff of McLennan County, Texas, ("Sheriff"), may release the Defendant to perform Defendant's employment duties or to attend Defendant's education related classes or required activities, as specified in the application and its attachments, on the following days during the periods specified below:

Defendant is **ORDERED** to notify the Sheriff's Department immediately if the above schedule changes or is interrupted in any manner, if such employment is terminated, or if Defendant ceases to be a student.

Defendant is **ORDERED** to return to or remain in the McLennan County Jail at all times Defendant is not performing his/her duties of employment or is not engaged in classes or required education related activities as set out in the schedule(s) attached to the application, including during holidays, bad weather days and other "breaks" or "time off," with the exception of meal breaks or regularly scheduled daily breaks.

It is **ORDERED** that the Sheriff's Department may, in its sole discretion, modify the above schedule to meet the needs of the Defendant or the Sheriff's Department.

Defendant is **ORDERED** to furnish to the Sheriff's Department documentation showing the days and hours worked during the last pay period within five calendar days of each of Defendant's pay dates.

Defendant is **ORDERED** to pay to the McLennan County Clerk ("Clerk"), P.O. Box 1727, Waco, TX 76703, reimbursement for court-appointed attorneys fees in this cause, court costs and any fine assessed, as set out in the Court's Payout Order entered in this cause, if any, and is further **ORDERED** to deliver a copy of the Court's Payout Order to Defendant's employer and to authorize Defendant's employer to withhold such amounts from Defendant's pay and to pay them directly to the Clerk. All amounts are due and payable on or before the first business day following each pay period. Payments by the Defendant's employer shall be credited to Defendant's obligation.

Defendant is **ORDERED** to pay to the Clerk a maintenance fee in the amount of \$5.00 per day for each day, or any portion thereof, that Defendant is released in compliance with this Order.
