The above fees do not include costs of publication, mailing, storage fees and other similar costs and expenses. To the extent permitted under applicable law, the person requesting service shall be responsible for all fees, costs and all expenses incurred.

All citations, precepts, writs or other process of service shall be mailed or delivered to the Constable of the Precinct where the service address is located.

All citations, precepts, writs or other process of service shall be served/delivered by the Constable of the Precinct where the service address is located.
